It is possible, that the confession of Lee may open the way to testimony more conclusive as to the part the First Presidency took in the inception and perpetration of the crime. We have always exposed the opinion that fanaticism cannot be urged in excuse of crime, if the fact of crime can be proved. Admitting that the Mormon leaders were sincere fanatics—that is, that they believed they were acting in obedience to the commands of the Lord in killing the enemies of the Church—the doctrine cannot for a moment be admitted that this belief may be legally urged in excuse for crime. Were such a principle established, every would-be murderer in the land would be a fanatic. We trust, however, that the confession of Lee will be allowed its full weight as a means of arriving at the truth. The methods by which the Mormon Church has maintained its ascendancy over the minds and bodies of its people are such as cannot be tolerated at this age of the world.

Brigham Must Die.

Lee's confession is circumstantial and consistent throughout. It convicted Haight, Bigbee, Dame, Allen and George A. Smith. The four survivors, if they can be captured and tried, will no doubt be able to tell exactly what part Brigham had in it; and this makes it of the highest importance that no pains shall be spared to arrest them. The Mormon Church, like that of the medieval Mohammedans, is in fact the Mormon State, and the head of it is as absolute as the Prophet of Mecca was. No such horror as the Mountain Meadows Massacre could possibly have been planned and executed without the foreknowledge of Brigham Young and his approval. That he ordered it is the general belief. That he kept the fatal secret, and closely guarded it with all his power and cunning for twenty years, everybody knows. He gave Lee up because some sacrifice was needed to save himself and the Church. But it is a poor atonement for such a crime, and justice demands that the real authors of it shall be made to pay the penalty as well as the wretched underlings.
